Additional Information

In 2017, Attorneys AJ Skogerson and Andrea McGinn combined forces to co-found The Law Shop ("TLS") in Van Meter, which was lowa's first private practice law firm providing unbundled legal services to nearly all clients. TLS quickly became an international leader in proving that offering high quality legal assistance on a limited scope basis increases access to justice for all while vastly improving the well-being of lawyers in a multitude of ways. In 2022, The Law Shop began serving more clients in rural SW lowa through their opening of The Pop Up Law Shop in Creston.

AJ and Andrea also now have a secondary company called The Law Shop Library. The Library provides access for select firms in other states to have the opportunity to create Law Shops of their own while AJ and Andrea provide Library Cardholders with customized coaching on office systems, management, and basic marketing. In 2023, TLS Minnesota was launched in the St. Paul area and discussions are currently in process for a potential TLS Arkansas in the coming year.

The Law Shop has been featured in The Iowa Lawyer, the Illinois Bar Journal, and the American Bar Association (ABA) Journal among other publications. NEWS FROM PUBLIC WORKS UTILITY RATE CHANGES

WATER

Effective July 1, the residential (inside the City of Van Meter) water rate will increase to \$27.09 for the first 2,000 gallons used per month and \$6.17 per 1,000 gallons over 2,000 gallons. The nonresident (outside the City of Van Meter) water rate will increase to \$90.42 for the first 2,000 gallons used per month and \$20.63 per 1,000 gallons over 2,000 gallons.

SEWER

Effective July 1, the residential (inside the City of Van Meter) sewer rate will increase to \$26.78 for the first 2,000 gallons used per month and \$7.87 per 1,000 gallons over 2,000 gallons. The nonresident (outside the City of Van Meter) sewer rate will increase to \$85.28 for the first 2,000 gallons used per month and \$25.06 per 1,000 gallons over 2,000 gallons.

THE RATE INCREASES WILL NOT REFLECT ON YOUR BILL UNTIL AUGUST 2024.
