from the Mayor's Desk

Another year passed and 2021 continued to have challenges with the COVID pandemic. The City continued to operate pretty much as normal. Most folks are more cautious and are aware there are still challenges out there and that we must remain vigilant and ensure we continue to help those in need and care for each other.

It was a busy year for the City of Van Meter. Our community continues to grow. We will do our best to ensure this is a controlled growth, so that we can maintain our small town feel and appeal, even though we are getting bigger.

We have three residential developments currently underway. 1) Grand Ridge Estates, at the Southwest corner of F-90 and R-16 saw a lot of progress this year. Dirt was moved around and Phase 1 streets were put in. They are continuing work to get ready for folks to start building. 2) Trindle Ridge west of Trindle Park off of R-16 is making progress. They have moved dirt, put in a street, and are installing sewer as part of that project. Much more progress will be made in 2022. 3) Hudson Heights, west of Hazel Street at the southwest edge of town, is the latest development that we expect to see things moving along in 2022.

We finalized the purchase of the ground for the new Van Meter Library on the Anderson property located south of the bridge/crane business ground on the west side of R-16.

We have been working on a water treatment plant for the City over a number of years. We were at a point several years ago where we were ready to get the project started. It was then brought to our attention that West Des Moines and Waukee were also looking to pursue a water treatment facility. They were looking north and east of Van Meter, which prompted us to pursue the possibility of a joint facility with them. It was a process bogged down with issues for our partners to work through. Recently, a new entity, Central lowa Water Works, was proposed. West Des Moines Water Works will vote in January to either continue with Waukee and Van Meter or join Central lowa Water Works. We are uncertain what direction they will choose and have little control over it. It may be that we will pursue the construction of our own facility. We will hopefully have answers in the next few months on what direction we will go. We keep hoping for the best solution for our community.

I want to give a huge thanks to all of our volunteers that give of their time to serve on our fire department, EMS, public safety, boards, committees, and commissions. For a small community, you are the lifeblood that allows us to stay safe and to thrive. We greatly appreciate all that you do to help us make our community one of the best places to live. Thank you!



Snow Ordinances

Snow Removal

No person shall park or allow a vehicle to remain parked on a public street in the city from curb to curb (or from the time all traveled portion of the roadway for those streets which do not have curbs) or 48 hours, whichever time is shorter. Vehicles shall be removed immediately once it begins to snow. The Director of Public Works and Utilities is also empowered to end the prohibition on parking prior to the expiration of the 48-hour period if the Director determines that the streets have been cleared. The Director of Public Works and Utilities shall notify the Police Chief when the parking prohibition has ended.

Dumping of Snow

• It is unlawful for any persons to throw, push, place or cause to be thrown, pushed or placed, any ice or snow from private property, sidewalks, or driveways onto the traveled way of a street or alley so as to obstruct gutters, or impede the passage of vehicles upon the street or alley or to create a hazardous condition therein; except where, in the cleaning of large commercial drives in the business district it is absolutely necessary to move the snow onto the street of alley temporarily, such accumulation shall be removed promptly by the property owner or agent. Arrangements for the prompt removal of such accumulations shall be made prior to moving the snow.

Removal of Snow, Ice and Accumulations

 It is the responsibility of the abutting property owners to remove snow, ice, and accumulations promptly from sidewalks. If a property owner does not remove snow, ice, or accumulations within 48-hours after such accumulations, the City may do so and assess the costs against the property owner for collection in the same manner as a property tax.
