- 10) Resolution #2019-52 Regarding Preliminary Plat of Survey Hudson Heights Plat 1. Paul Clausen of CEC was present to represent the project. Mr. Clausen provided responses to the questions and concerns raised during the September 9th Council meeting. Additional questions were asked by Council and citizens present. City Staff and Mr. Clausen provided answers and explanations regarding stormwater management practices and road access. Coyle moved supported by Herman to approve the Preliminary Plat of Survey as submitted. On roll call the votes were as follows: Sacker YES; Coyle YES; Herman YES; Lyon YES; Meyer NO. Motion passed.
- 11) Resolution #2019-57 Regarding setting date for a Public Hearing on Urban Renewal Plan Amendment. City Administrator Michel indicated that it was time to take action on the Urban Renewal Plan Amendment to allow for the continuation of internal loans for the economic development practices of the City.
