


City of Van Meter, Iowa

City Council Minutes – 8-24-2022

- 1) The Van Meter City Council met for a council workshop on Wednesday, August 24, 2022, at the Veterans Reception Center, 910 Main Street. Mayor Adams called the meeting to order at 6:00 pm. The following council members were present upon roll call: Travis Brott, Blake Grolmus, Joe Herman, Lyn Lyon, and Craig Greer.  
Staff present: Assistant Police Chief Mike Brown, Firefighter Jeremy Feldman, City Attorney John Fatino, City Clerk Liz Thompson, and Deputy City Clerk Grace Grob.
- 2) Mayor Adams asked for a motion to approve the agenda. Brott moved, supported by Grolmus, to approve the agenda. On roll call the votes were as follows: Brott – YES; Grolmus – YES; Herman – YES; Lyon – YES; Greer – YES.
- 3) Discussion and Possible Action
  - a. Discussion to remove Chapter 31 “Public Safety Department” of the City Code of Ordinances and modify other sections was had. A motion to set public hearing date for the DPS Code Change for the September 12, 2022, Council Meeting was made by Brott, supported by Greer. On roll call the votes were as follows: Brott – YES; Grolmus – YES; Herman – YES; Lyon – YES; Greer – YES.
  - b. A motion by Lyon, supported by Grolmus was made to approve Bill Daggett’s request to keep his DPS badge and FD Helmet Badge. On roll call the votes were as follows: Brott – YES; Grolmus – YES; Herman – YES; Lyon – YES; Greer – YES.
  - c. Fire Chief Schmitt provided a quote to council for repairs to the brush truck. Grolmus made a motion to authorize spending on the quote, supported by Greer. On roll call the votes were as follows: Brott – YES; Grolmus – YES; Herman – YES; Lyon – YES; Greer – YES.
- 4) Presentation – Matt Stoffel of PFM presented financial models to the council regarding the City’s G.O. Debt Capacity. No action was taken.
- 5) Closed Session Pursuant to Iowa Code 21.5(1)(C) and 21.5(J). Grolmus moved, supported by Brott to enter closed session at 7:57 PM. On roll call the votes were as follows: Brott – YES; Grolmus – YES; Herman – YES; Lyon – YES; Greer – YES. Mayor Adams excused the public and staff not needed for the closed session at 7:57. Mayor Adams returned the meeting to open session at 8:45.
- 6) Greer moved to adjourn; supported by Grolmus. Motion carried unanimously. The mayor adjourned the meeting at 8:45 pm.
