NEWS FROM CITY HALL V



The regular city/school election will be held on November 7, 2023. The filing period for the city/school election candidates begins on Monday, August 28, 2023 and closes on Thursday, September 21, 2023 at 5:00pm. Nomination papers must be filed with the Dallas County Auditor during the filing period. They cannot be filed before or after the filling period.

The City of Van Meter has 4 positions to fill this election cycle: three (3) council seats and the Mayor's seat. All candidates must be residents of the City of Van Meter. All candidates for City vacancies must complete and submit an Affidavit of Candidacy and nomination petition with at least 10 signatures to the Dallas County Auditor by the deadline.

The Van Meter School Board has 2 seats up for election this year. Please contact the school for more information.

CODE REMINDER

As a friendly reminder, it is illegal to discharge grass clippings and yard waste into the public streets or sidewalks while mowing. Grass clippings in the street ultimately end up in a storm drain were they can build up and cause drainage issues and localized flooding.

CHAPTER 135.03 - STREETS - PLACING DEBRIS ON.

It is unlawful for any person to throw or deposit on any street or alley any glass, glass bottle, nails, tacks, wire, cans, trash, garbage, rubbish, litter, offal, leaves, grass or any other debris likely to be washed into the storm sewer and clog the storm sewer, or any substance likely to injure any person, animal or vehicle. (Code of lowa, Sec. 321.369)

CHAPTER 136.17 - SIDEWALKS - DEBRIS.

It is unlawful for a person to throw or deposit on any sidewalk any glass, nails, glass bottles, tacks, wire, cans, trash, garbage, rubbish, litter, offal, or any debris or substance likely to injure any person, animal or vehicle. (*Code of Iowa, Sec. 364.12[2]*)

Yard waste is collected on Thursdays. Waste Connections allows unlimited bags of yard waste as long as they are in the biodegradable compost/yard waste bags less than 50 lbs.

Twigs and small branches may be in securely tied bundles no more than 4 feet in length or wider than 18 inches in diameter.

Yard waste collection runs through November each year.



Please do not burn anything in the street culverts including but not limited to yard waste, tree trimmings, leaves, etc.

NEWS FROM PUBLIC WORKS

WATER METER REPLACEMENT

Public Works is working on replacing all water meters within the City of Van Meter. This is at no additional cost to the resident but may require installation. Please be on the lookout for a door hanger with more information. Installation of the new meters will improve operational efficiency, increase consumer visibility through a customer facing portal, allows for high usage or continuous usage alarms to be set and decrease the amount of time staff needs to perform monthly utility billing operations.







There are several construction sites throughout the town which may contain areas of safety hazards. Please steer clear of the new construction sites and remember that entering a construction zone is not only a potential safety hazard but also may be considered trespassing.

Please be aware of construction traffic and staff in both construction areas and along the roadways.

There are several projects slated to begin this fall in the City Right-Of-Ways including tree removal, fire hydrant repair & maintenance, service line maintenance, etc. There will be City Staff and contractors working in the City Right-Of-Ways.

WATER BOOSTER STATION

The Van Meter City Council awarded the construction bid for the Water Booster Station project in early 2023. The installation of the Water Booster Station is necessary to increase pressure in the distribution system.

The Water Booster Station will be located on the East side of Richland Road.

During construction, there may be service areas within the City that experience disruptions to their water service. The City will provide notice prior to disruption.

Construction is set to begin this fall.





NEWS FROM THE POLICE DEPARTMENT

TRAFFIC CONTROL UPDATES

On June 12, 2023, the Van Meter City Council discussed a proposed special speed zone of 35pmh on Mill Street/R16/Veteran's Parkway from North of the Raccoon River Bridge to 340th Trail. They set a public hearing for July 10, 2023 at the Veteran's Reception Center at 7:00pm.

The Public Hearing was held on July 10, 2023. No comments were received prior to the hearing and 1 question was raised by the public during the hearing. The Van Meter City Council passed the ordinance creating a new special speed zone on Mill Street from the North side of the Raccoon River Bridge to 340th Trail for both North and South bound traffic.

The new speed signs were recently installed.

Please watch your speed.





On May 22, 2023, the Van Meter City Council discussed traffic control signage at Main Street and Wilson Street stopping North-bound traffic and South-bound traffic on Wilson Street, creating at four (4) way strop at that intersection.

Resolution #2023-49 was adopted with a vote of 5-0.

Public Works recently installed the stop signs and will be painting the crosswalks in coming weeks.

Tween Scene will also be returning some time in September! Our focus will be on STEM/STEAM activities. Be on the lookout for more information coming soon!




