CHAPTER 75 UTV, GOLF CART, SNOWMOBILE, AND ATV OPERATIONS CHANGE

Do you own a UTV, ATV, or Golf Cart? The Van Meter City Council updated Chapter 75 of the Van Meter Ordinances regarding these vehicles. UTVs and Golf Carts now have new requirements before being operated on city streets.

This ordinance permits the operation of "UTVs" (Off-road Utility Vehicles) and Golf Carts on certain streets in the city, as authorized by Section 321.247 of the Code of Iowa as amended, and regulates the operation of snowmobiles within the city limits. This chapter applies whenever a UTV, Golf Cart, or Snowmobile is operated within the City of Van Meter and when UTVs or Golf Carts are operated on any street or alley, subject to those exceptions stated herein.

UTVs & Golf Carts may be operated upon the streets of the City by persons who are 18 years of age or older and possess a valid driver's license. While operating on a City Street, the number of passengers permitted on a UTV or Golf Cart shall not exceed the number of seats intended for passengers. While on city streets, operators must have proof of the required insurance on their person or in the UTV or Golf Cart. Both driver and passengers must always wear seat belts for UTVs and keep feet and hands inside the vehicle while the vehicle is in motion. Towing of persons for business purposes is only allowed in a trailer manufactured for such purpose that has not been altered from the manufacturer's specifications.
